
The program started with welcome remarks from PRA president Dr. Julie T. Li-Yu followed by the meeting overview by the Continuing Medical Education (CME) chair, Dr. Emmanuel C. Perez.

Another informative lecture was provided by Dr. Inocencio P. Alejandro on the 3Ds in Geriatrics: Delirium, Dementia and Depression. His highlighted presentation the interaction among the 3Ds and chronic arthritis in the geriatric setting. The next lecture was a discussion on the medication management and polypharmacy in the elderly by Dr. Joseph Patrick N. Patricio.

A lunch symposium provided by Mylan on update on ESCEO guidelines on OA management was led by Dr. Ester G. Penserga.

The afternoon sessions began with a basic science lecture on by Dr. Patricia Pauline M. Remalante, which reviewed osteoarthritis (OA) pathophysiology

as it relates to chronic pain, and further discussions on new innovative treatment targets in OA. Following this, Dr. Lenore Rosario L. Lizardo presented an overview of the EULAR updates on OA focusing on translational research and clinical management.

Another relevant lecture was provided by Dr. Melissa L. Aquino-Villamin on quality of life issues in OA. An interactive session on the clinical approach to osteoarthritis came in next with the multidisciplinary team consisting of Dr. Michael Thomas E. Salvador (rheumatologist), Dr. Charles Abraham C. Villamin (orthopedics) and Dr. Svetlana Olaso (physiatrist) as panelists. Α dinner symposium followed which addressed the role of biologics in geriatric rheumatology.
